In today's conditions of increasing threats and dangers of various forms, ensuring peace and tranquility, protection of human rights, freedoms, legal interests, as well as public safety in the country, in each of its neighborhoods, even in the most remote villages. , in particular, remains one of the most urgent and complex tasks of internal affairs bodies.
